MEMORANDUM: SP 13-2025, CACFP 10-2025, SFSP 06-2025: FULL-YEAR CONTINUING APPROPRIATIONS AND EXTENSIONS ACT, 2025: EFFECT ON CHILD NUTRITION PROGRAMS

This memorandum provides notice to Child Nutrition Program operators regarding the Full-Year Continuing Appropriations and Extensions Act, 2025. This applies to State agencies administering, and local organizations operating, the U.S. Department of Agriculture (USDA), Food and Nutrition Service (FNS), child nutrition programs.



SP 12-2025: PAID LUNCH EQUITY: GUIDANCE FOR SCHOOL YEAR 2025-2026

This memorandum provides guidance to State agencies and school food authorities (SFAs) on the paid lunch equity (PLE) requirements for school year (SY) 2025-2026. This memorandum explains the paid lunch equity PLE exemption provided in Full-Year Continuing Appropriations and Extensions Act. This memorandum also provides guidance for SFAs that do not qualify for the exemption.

FRESH FRUIT AND VEGETABLE PROGRAM END OF PY24-25 SURVEY DUE JUNE 30, 2025

All Fresh Fruit and Vegetable Program (FFVP) operators are required to complete the FFVP End of Year Survey by Monday, June 30. Survey responses will be used to determine eligibility for the BRAVOcado! Excellence Awards.



APPLICATIONS FOR PROVISION 2/3 BASE YEAR AND CEP DUE JUNE 30, 2025

SFAs wishing to apply for a Special Provision Option (Provision 2, Provision 3, or CEP) in SY 2025-26 must submit a complete Special Provision Option Application packet to HNS by June 30.

Submit SY 2024-2025 Claim(s) Now!

REDUCED-PRICE MEAL SUBSIDY EXPIRES

The reduced-price meal subsidy for SY 2024-2025 is expiring. **All reimbursement claims** for SY 2024-2025 should be submitted prior to **June 22, 2025**, in order to be processed in time to receive the subsidy.

Should June operations not exceed more than 10 days, the May and June claims can be combined. Per 7 CFR 210.8 (c)(1) At the end of the school term, May and June claims may be combined if not more than 10 days of program operation occurred in June. June claims that exceed 10 days and cannot be combined with May claims will not receive the reduced-price subsidy payment.

Any one-time exception claims submitted, or reimbursement holds released after June 22, 2025, will not get paid the reduced-price subsidy payment.



CEP Annual Timeline

April 1

SFAs determine identified student and enrollment counts

April 15

Deadline for LEAs to submit identified student and enrollment counts to ADE for each site within CNP Direct Certification in ADEConnect 'CEP Data Collection'

May 1

ADE publishes a site level notification list of all eligible and near eligible CEP sites

June 30

CEP application and supporting documentation are due to ADE

Paid Lunch Equity

WHY PAID LUNCH EQUITY MATTERS

School Food Authorities (SFAs) involved in the National School Lunch Program (NSLP) are required to establish prices for paid lunches at a price, that is on average, equal to the difference between free meal reimbursement and paid meal reimbursement. This obligation can be fulfilled either through charging for paid meals or through non-Federal contributions made to the non-profit school food service account.

PLE guarantees that:

- Schools do not charge less for meals than the actual production costs.
- Federal funds designated for free and reduced-price lunches do not subsidize meals for paying students.
- Schools have the necessary funding to provide nutritious meals to all students.

Paid Lunch Equity

ANNUAL REQUIREMENTS

All School Food Authorities (SFAs), regardless of their current lunch prices, are required to conduct an annual review of their paid lunch prices to comply with the Paid Lunch Equity (PLE) requirement by using the USDA Paid Lunch Equity (PLE) Tool for the current year. **However, certain SFAs are NOT required to complete the Annual PLE Tool.**

School Food Authorities (SFAs) that are not required to complete the Annual PLE Tool include:

- SFAs that qualify for the school year 2025-2026 PLE exemption;
- Community Eligibility Provision schools;
- Non-pricing programs such as Provision 2 schools.



Paid Lunch Equity

QUALIFYING FOR THE SY 2025-2026 PLE EXEMPTION



Exempt

SFAs with a **positive or zero balance** in the nonprofit school food service account as of June 30, 2024, are exempt from PLE pricing requirements for SY 2025-2026. This can be shown with their current Annual Financial Report (AFR).



Not Exempt

SFAs that do not qualify for the PLE exemption due to a **negative balance** in the nonprofit school food service account as of June 30, 2024, **must follow PLE requirements** when establishing their paid lunch prices for SY 2025-2026.

OPTIONAL TOOL FOR EXEMPT SFAS

While not required, exempt SFAs may choose to use USDA's PLE tool to complete the steps necessary to determine their target SY 25-26 paid lunch price and adjust their paid lunch prices accordingly.

Paid Lunch Equity

GUIDANCE FOR SY 2025-2026 PAID LUNCH PRICING

- SFAs may use the prices they last charged students as the basis for their SY 2025-2026 paid lunch price calculation, even if those prices were charged during a year the SFA was not required to comply with PLE requirements.
- If an SFA did not charge for meals during SY 2024-2025, such as an SFA that operated the Community Eligibility Provision, or Provisions 2 or 3 and is returning to standard counting and claiming in SY 2025-2026, they may use the most recent paid lunch price data as the basis for its SY 2025-2026 paid lunch calculation.
- SFAs are not required to raise their paid lunch price by more than 10 cents for SY 2025-2026 from the last year they charged for paid lunches. SFAs can still choose to raise the price by more than **10 cents**.

SFAs must show a zero or positive balance in their non-profit food service account to be exempt from PLE requirements this year. This can be shown with the Annual Financial Report (AFR).



SUN Bucks Household Application

BENEFIT ISSUANCE

Households with SUN Bucks eligible children will receive an EBT card with \$120 total for purchasing groceries in the summer months. Households on an active SNAP/TANF case will receive funds on their current EBT card. Benefits distribution has begun.

Funds are subject to expungement at four months (122 days) after benefits are made available.

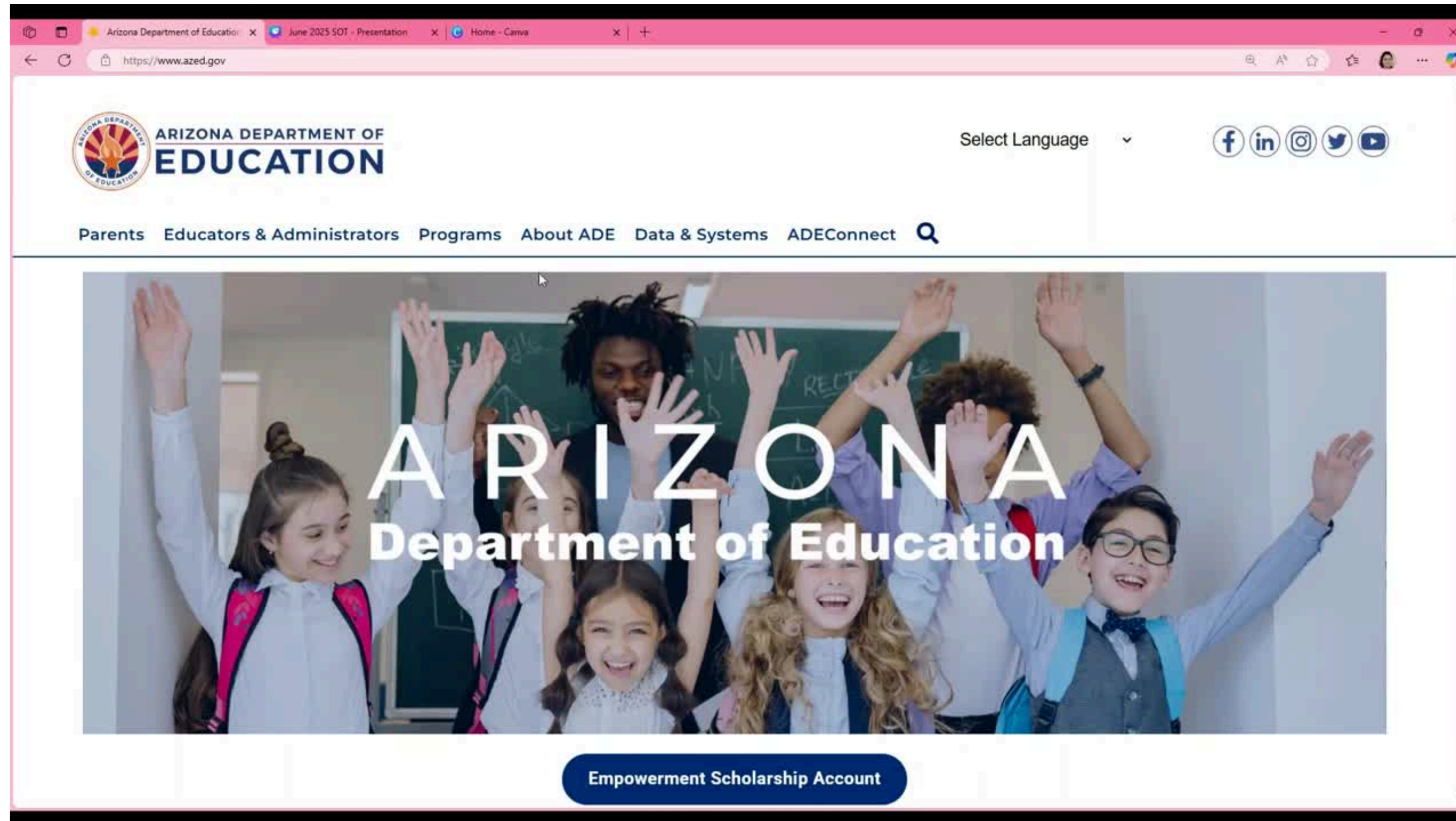


SUN Bucks Eligibility Screener Guide:

- Most eligible students will qualify automatically and will not need to fill out a SUN Bucks application.
- Families of students that did not qualify automatically but believe they are eligible must use the SUN Bucks Eligibility Screener to determine if their child is eligible to apply for SUN Bucks benefits.
 - If the screener determines that the child is eligible, the link to the SUN Bucks application will be provided in the Screener.

The SUN Bucks – Summer EBT 2025 Application is available and can be accessed in the SUN Bucks Eligibility Screener.

School Food Authorities (SFAs) are required to:

- Ensure the application is available to households that believe they qualify for the SUN Bucks benefit but were not identified as eligible by the SFA.
- Report all students who attended schools participating in a Special Provision Option, who were not directly certified but may be eligible.

Eligible households may:

- Complete and submit the 2025 SUN Bucks Application by first completing the SUN Bucks eligibility screener tool to the Arizona Department of Education (ADE) by **August 5, 2025** (subject to date change)
- Expect ADE to process the application and subsequently notify the household of approval/denial of benefits.

SUN Bucks: Summer Electronic Transfer (Summer-EBT)



The Summer Electronic Benefit Transfer Program (SEBT) provides grocery-buying benefits to low-income families who lose access to free or reduced-price school meals during the summer.

Most children in Arizona will automatically receive benefits and do not need to apply.

Do You Need to Apply? Before applying for SUN Bucks, please review the "Do you automatically get SUN Bucks?" section on this page or complete the Eligibility Screener Guide ([English](#) or [Spanish](#) version) to determine if your child will receive benefits automatically. Completion of the eligibility screener will provide the link to the application if applicable.

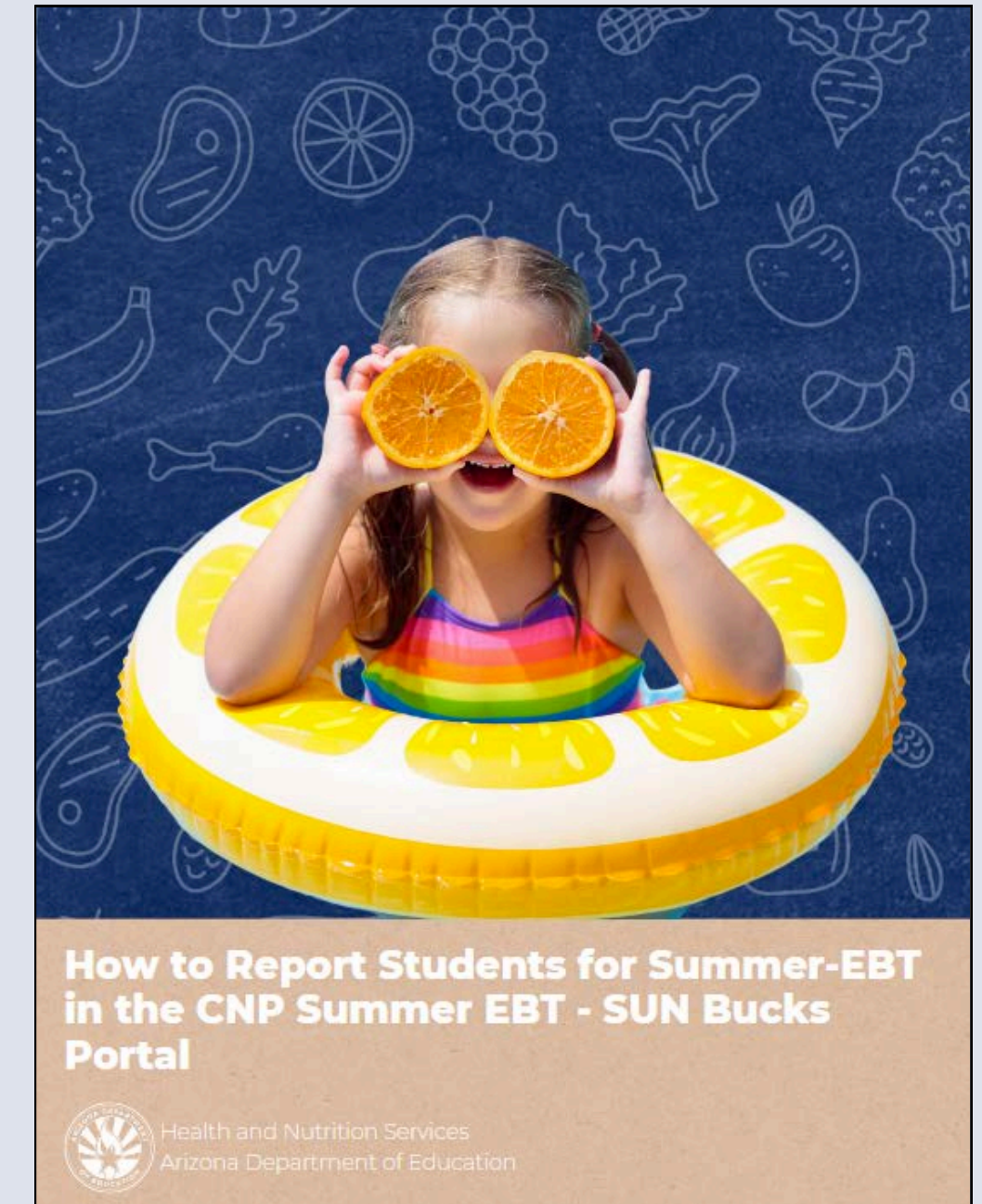
You must submit an application by August 5, 2025.

Reporting Students for SUN Bucks Benefits

CNP SUMMER EBT - SUN BUCKS PORTAL

All SFAs must contact their Entity Administrator to request permissions to the CNP Summer EBT - SUN Bucks portal for the appropriate users to gain access. SFAs must ensure all data is correct/submitted by the **August 5, 2025 deadline**.

- **SFAs with AzEDs reporting NSLP schools**: SFAs must view pre-populated AzEDs enrollments, free/reduced-price eligibility information, and report any students (and f/r eligibility information) not already pre-populated by ADE.
- **SFAs with non-AzEDs NSLP schools**: SFAs must add all 2024-2025 enrolled students and free/reduced eligibility information.

Eligibility Source Report and SPO Operators

Those sites that operate a Special Provision Option (SPO) like the Community Eligibility Program, or Provision 2 or 3 that do not collect school meal applications will only be able to report the following students:

- Match results from the CNP Direct Certification system

No Meal Application, No Problem...

How to receive SUN Bucks for students who attend schools that do not collect Household Applications for Meal Benefits



The information collected on meal applications for the National School Lunch Program (NSLP) can qualify students for SUN Bucks. However, if your school doesn't collect meal applications, you may fill out a SUN Bucks application to see if your child is eligible for this grocery buying benefit.

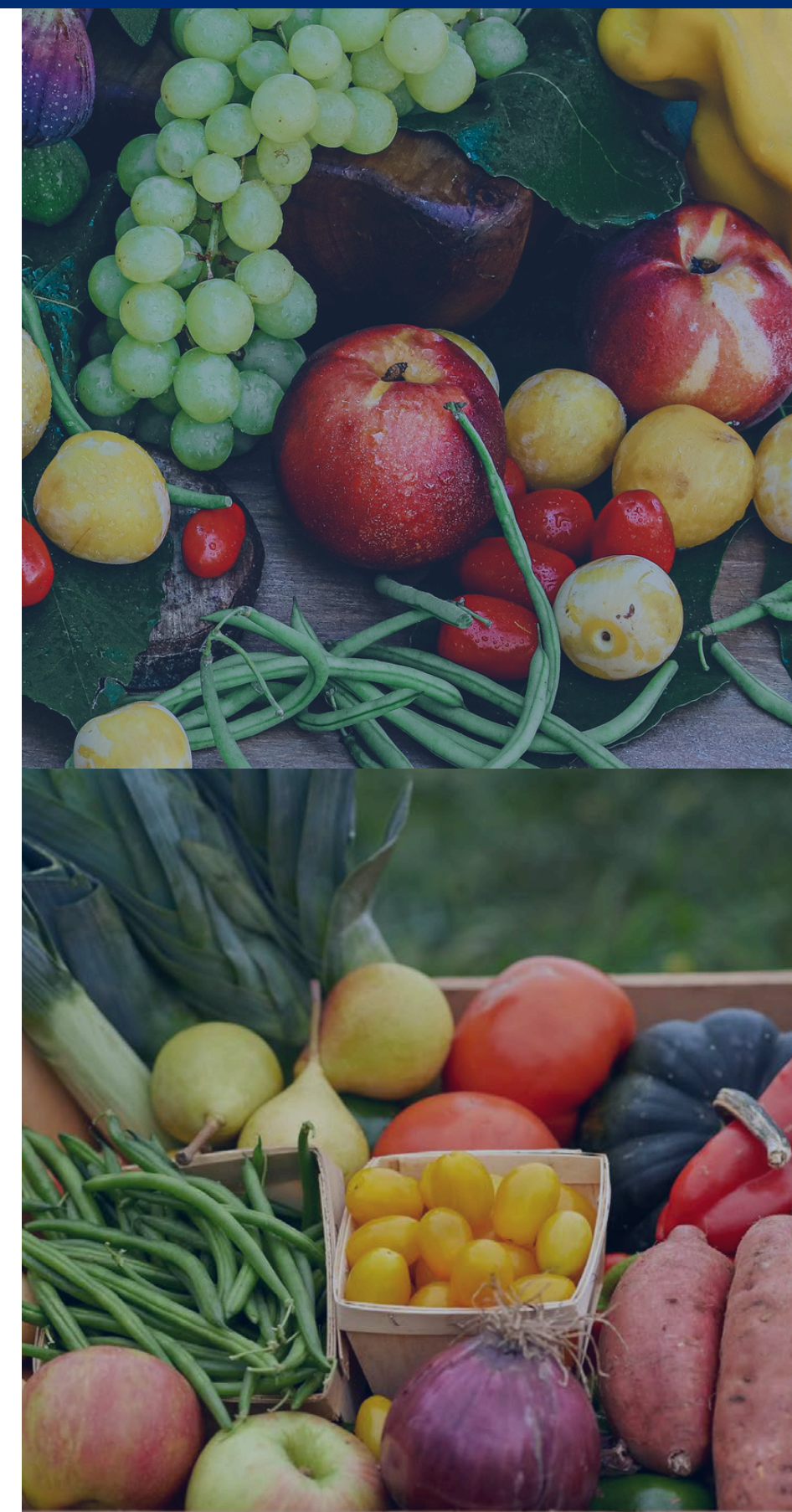
DATES AND REMINDERS

- **May 23, 2025:** Was the final day for shipments from Shamrock Foods. Please ensure all USDA Foods shipments are verified in the myFOODS system.
- **June 30, 2025:** DoD Fresh has all remaining SY25 NSLP funds available to SFAs on a first-come, first-served basis until June 30, 2025.
- **July 1, 2025:** DoD Fresh SY26 NSLP funds will be ready for use just in time for meals on the first day of school.

To ensure food safety with cucumbers, always thoroughly wash them under running water before eating, cutting, or cooking, even if you plan to peel them.



ARIZONA HARVEST FACTS

- Composed of about 95% water, cucumbers are excellent for staying hydrated.
- Cucumbers provide vitamins K, C, and several B vitamins, essential for various bodily functions.
- Cucumbers are a classic ingredient in salad and often used in sushi rolls because they offer a crisp texture.
- English Cucumbers: Also known as hothouse cucumbers, they are long, thin, and have a mild flavor.
- Kirby Cucumbers: These small, bumpy cucumbers are ideal for pickling due to their firm texture.
- Persian Cucumbers: Smaller and sweeter than regular cucumbers, they are perfect for snacking.
- Lemon Cucumbers: Round and yellow, these cucumbers have a slightly citrusy flavor.

LOCAL RECIPE:

Cucumbers with Chili & Lemon

Serving size: ½ cup, Yield 10 servings
Credits: ½ cup Other Vegetable

- 2 pounds unpared cucumbers
- 2 Fresh lemons (or limes)
- 2 tbsp. Ground Chili Powder

Slice the cucumbers into thin coins. Fresh lemon juice adds the right amount of tanginess. If you prefer lime, you can swap out lemon juice with lime juice in this recipe. The amount of chili powder is completely up to the flavor you want to create. Add more for an added kick! Combine ingredients in a large bowl. Toss and serve.

SY 25-26 State Match Funding Requirements

FOR DISTRICT AND CHARTER SCHOOLS

The amount of state match funding required for each school district and charter school, that receives State appropriate funds, is equal to **30% of the total number of lunches served through NSLP in the previous school year**, multiplied by the paid **lunch reimbursement rate for 2024-2025**.

State Match Funding Rates

HNS TA 01-2025: SY 25-26 STATE MATCH REQUIREMENTS

For SY 2024-25, the paid lunch reimbursement rate was either \$0.42 or \$0.44, depending on the school's eligibility for the regular or high rate, plus the additional \$0.09 received by menu-certified districts and charter schools, if applicable.

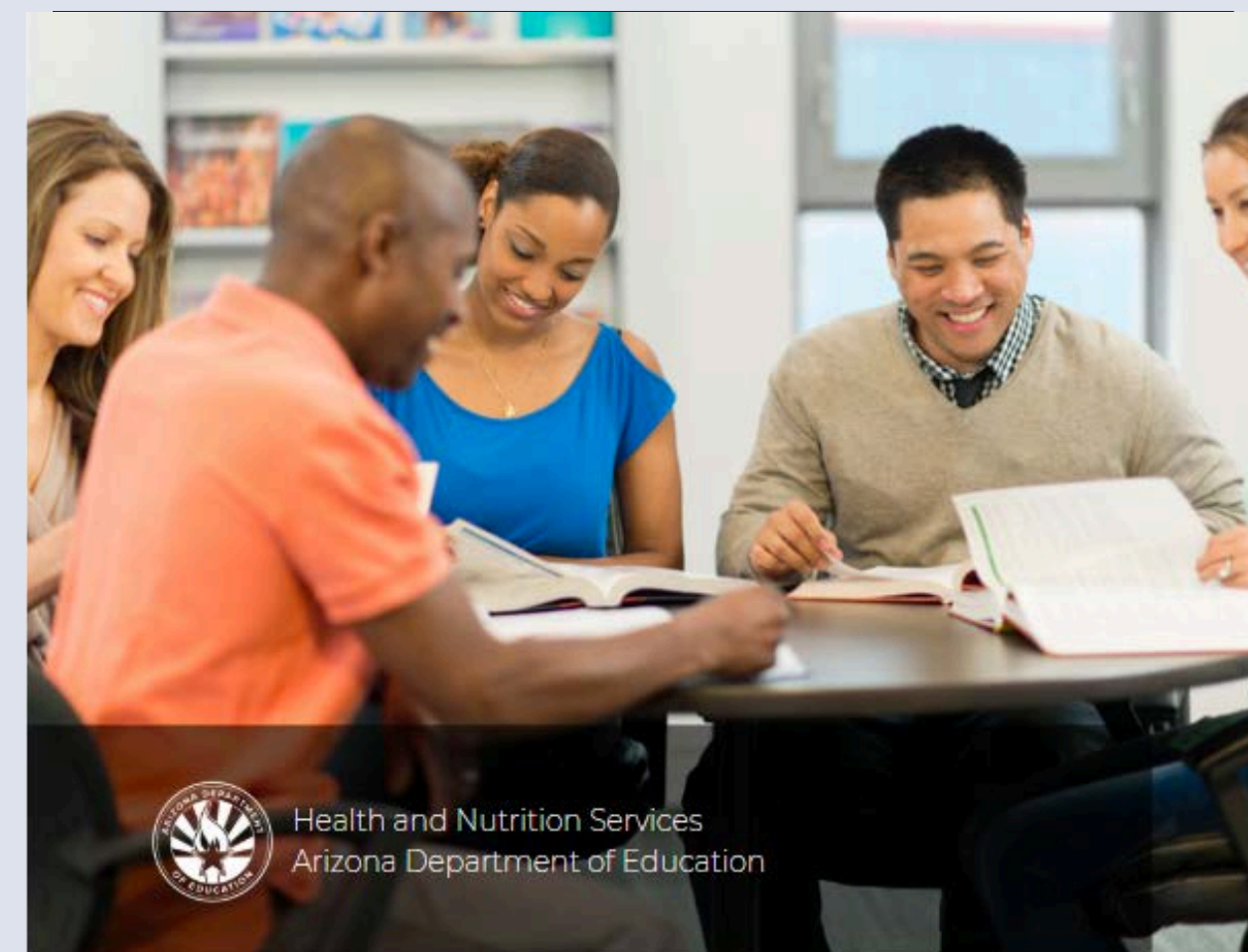

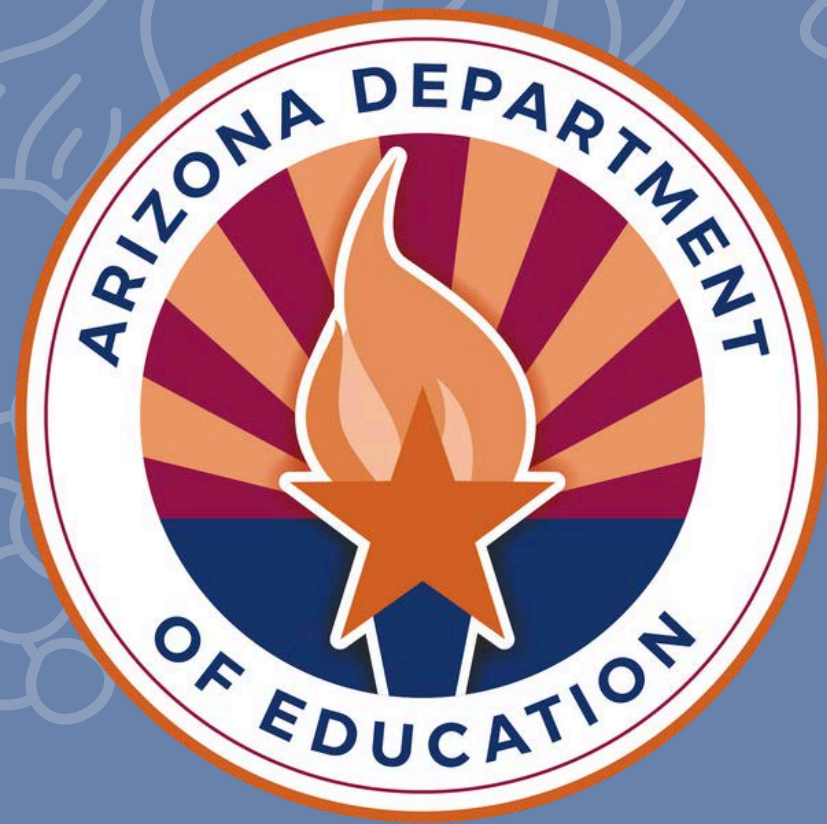
