# SCHOOL YEAR 2025-2026 OPTIONAL PAID LUNCH EQUITY (PLE) TOOL IS NOW AVAILABLE!

The USDA has released the School Year 2025-2026 (SY26) Optional Paid Lunch Equity (PLE) Tool to assist School Food Authorities (SFAs) with meeting the PLE requirement.

While the PLE tool is mainly the same as the one released last school year (except for the reimbursement differences that are used), minor updates were made based on user feedback received.

### CIVIL RIGHTS REQUIREMENT: NOTIFICATION OF FREE LANGUAGE SERVICES

This is a reminder that all Child Nutrition Program (CNP) operators are required to notify the public of free language services.

The Arizona Department of Education Health and Nutrition Services (HNS) recommends that CNP operators comply by including a statement on their website homepage that reads:

"Free language assistance, auxiliary aids, and/or accommodations are available upon request. For more information, please contact [input contact information]."



# UPDATED TRAINING: HOW TO SUBMIT A SUMMER MEAL SERVICE CLAIM, NOW INCLUDING NON-CONGREGATE SUMMER MEAL SERVICES

The Arizona Department of Education (ADE) Health and Nutrition Services (HNS) has updated the How to Submit a Summer Meal Service Claim in CNPWeb training to reflect the new fields in CNPWeb that will capture non-congregate site claims and hybrid (congregate and non-congregate) site claims. HNS recommends operators offering non-congregate meals review this resource for the updated claiming guidance. The updated guidance can be found starting on slide 18 of this training.

#### REMINDER FOR SCHOOL MEAL PROGRAMS: UPDATED NUTRITION STANDARDS

- IMPLEMENTATION BY JULY 1, 2025, WITH UPDATED RESOURCE

HNS issued a reminder about updates to the <u>school nutrition standards</u>. While some changes to the meal pattern requirements are phased in through school year (SY) 2027-2028, several changes are effective July 1, 2025.

#### IMPLEMENTATION BY JULY 1, 2025

#### **ADDED SUGARS**

Schools must meet the following productbased added sugar limits:

- Breakfast cereals must contain no more than 6 grams of added sugars per dry ounce (7 CFR 210.10(c)(2)(iii)(B)).
- Yogurt must contain no more than 12 grams of added sugars per 6 ounces (2 grams per ounce) (7 CFR 210.10(c)(2)(iv)(C)).
- Flavored milk must contain no more than 10 grams of added sugars per 8 fluid ounces, or 15 grams of added sugars per 12 fluid ounces for flavored milk sold as a competitive beverage for middle and high schools (7 CFR 210.10(d)(1)(iii)).



#### **NSLP AFTERSCHOOL SNACKS**

Schools serving NSLP afterschool snacks to children in grades K-12 must serve the meal components and quantities found at <u>7 CFR</u> 210.10(o)(2). Two highlights include:

- No more than half of the weekly fruit or vegetable offerings at NSLP snacks may be in the form of juice.
- At least 80 percent of the grains offered during the week for NSLP snacks must be whole grain-rich.
- Grain-based desserts, except for sweet crackers such as animal and graham crackers, do not contribute toward the grains requirement.

#### IMPLEMENTATION BY JULY 1, 2025

The final rule titled, Child Nutrition Programs: Meal Patterns Consistent With the 2020-2025 Dietary Guidelines for Americans, effective July 1, 2024, is following phased-in implementation for required changes. The following NSLP and SBP meal pattern changes must be implemented by July 1, 2025:



#### **MEAL MODIFICATIONS**

Schools must accept medical statements from registered dietitians requesting meal modifications on behalf of students with disabilities in the school meal programs. Refer to **7 CFR 210.10(m)(1)(i)** for more information.



### SUBSTITUTION OF VEGETABLES FOR FRUITS AT BREAKFAST

Schools that choose to substitute vegetables for fruit at breakfast one day per school week may offer any vegetable, including a starchy vegetable. Schools that choose to substitute vegetables for fruit at breakfast on two or more days per week are required to offer vegetables from at least two different vegetable subgroups. Refer to SP 02-2025 and SP 13-2025 for more information.

#### **SODIUM**

The current sodium limits at breakfast and lunch will remain in place until **July 1, 2027**. Schools are encouraged to gradually work toward meeting the future sodium requirements (7 CFR 210.10(c)). #### **BUY AMERICAN**

Schools' non-domestic food purchases must not exceed 10 percent of total annual commercial food costs as outlined in 7 CFR 210.21(d)(5)(ii)(A) and 7 CFR 220.16(d)(5)(ii)(A). As outlined in recent guidance, State agencies have the ability to approve a temporary accommodation to those school food authorities that demonstrate they cannot meet the threshold requirement for non-domestic purchases (see SP 09-2025).

#### Buy American Accommodation

### HNS 05-2025

Beginning July 1, 2025, SFAs must ensure non-domestic food purchases do not exceed 10 percent of total annual commercial food costs.

If an SFA demonstrates they are unable to meet the requirement, HNS will offer an accommodation that will temporarily allow the SFA to exceed the 10 percent threshold for non-domestic food purchases. HNS will provide technical assistance to SFAs to support the temporary accommodation consistent with the availability of the two regulatory exceptions for non-domestic purchases.

To receive this temporary accommodation, SFAs must complete the <u>Buy American Accommodation Plan</u>.

# BUY AMERICAN ACCOMMODATION PLAN REQUIREMENTS

- Contact Information
- Reasonable explanations of why the accommodation is needed and the 10% threshold is being exceeded. Examples:
  - timing of the procurement cycle;
  - student preference/anticipated participation impacts;
  - items that help meet meal standards;
  - o items that facilitate meal service models.
- Categories of food that require the accommodation
- Anticipated timeline to make modifications to meet the Buy American requirement




### Applying for SY 25-26

SFAs applying to participate in school meals programs and USDA Foods in Schools program during SY 25-26 must complete the following:

- CNPWeb Site and Sponsor Applications
- CNPWeb Checklist Items
- Additional Documentation Requested by the HNS Specialist
- myFOODS activation

SFAs should submit all application components as early as possible and allow three weeks for the application approval process to be completed. SFAs must ensure that all applications and all required components are submitted with adequate time for approval and to meet claiming deadlines.

For SY 2025-2026 operators will continue to submit applications and claims in CNPWeb.



#### CNPWeb Checklist Items

## APPLICATIONS WILL NOT BE APPROVED UNTIL ALL CHECKLIST ITEMS HAVE BEEN RECEIVED AND APPROVED

- Custom, scannable, or electronic household meal application, parent letter, and/or notification of meal benefits
- Contractual agreements for vended meal service (Food Service Management Company, Caterers, SFAs serving as caterers)
- At-Risk Meals Component Principal Addendum
- Department of Economic Security (DES)/ Department of Human Services (DHS) License
- 501(c)(3) tax-exempt status
- Free and Reduced-Price Policy Statement/Addendums
- Food Program Permanent Service Agreement



Program operators may be requested to submit Area Eligibility documentation for sites operating At-Risk/ASCSP that are using school level data other than the site.

# Annual SNP Training Requirements

SFAs must ensure that all new and current school nutrition program staff meet the minimum annual training requirements per USDA's Professional Standards regulations. HNS has drafted a specialized <a href="NSLP Training Curriculum">NSLP Training Curriculum</a> based on job duties.

Civil Rights Training is required annually. HNS provides a Civil Rights Compliance for Child Nutrition Operators.

ONLINE COURSE (<u>English</u>) (<u>Spanish</u>).

SNP directors, management, and staff tasked with NSLP procurement responsibilities must complete training on Federal procurement standards annually. HNS provides a <u>Procurement Basics</u> ONLINE COURSE.



### Prior to School Starting

#### **MAKE SURE TO:**

- Provide outreach to households for School Breakfast Program (SBP) at the beginning of school and at least once again during the SY (required only if operating SBP).
- Print HNS' Training Curriculum & Brochure. Go to: <a href="https://www.azed.gov/hns/nslp/training">https://www.azed.gov/hns/nslp/training</a>
- Create Professional Standards plans for all School Nutrition Program Staff, including mandatory Civil Rights training.
- Post point of service (POS) meal signage. Train Offer vs. Serve (OVS) to all staff, if applicable.
- Annual training on procurement for required individuals, reviewing all procurement methods (micro, small, and formal) prior to purchasing.
- Update Adult Meal Prices.
- Set meal prices in accordance with Paid Lunch Equity (PLE).

### Confidential Information

#### **DISCLOSURE OF NSLP ELIGIBILITY INFORMATION**

Students' NSLP/SBP eligibility information shall not be made available to all school officials as a general practice.

Although a program or person may be authorized under the National School Lunch Act to access students' free and reduced-price eligibility information, there must be a legitimate "need to know" to provide a service or carry out an authorized activity. 7 CFR 245.6 (f)(3): The SFA may disclose children's eligibility status only to persons determined to be "directly connected" with the administration or enforcement of a Federal education program, State education program, or a means-tested nutrition program, as well as to persons directly connected with the Comptroller General Office or law enforcement for an authorized activity.

7 CFR 245.6(f)(3)(i): LEAs must ensure data systems, records, and other means of accessing a student's eligibility status are limited to officials directly connected with administration or enforcement of a Federal or State program or activity.



SFAs are encouraged to review Section 5 of the Eligibility Manual for School Meals for more guidance.

## USDA Foods in Schools in SY 25-26

#### **MYFOODS SYSTEM UPDATES**

The myFOODS system has rolled to the new school year. All system dates will default to SY 25-26.

<u>Systems Manual</u> for system functions.

#### **ACTION ITEMS**

- Existing users must update any contact and site information within the system.
- **New users** of the myFOODS system must contact ADE for access by emailing <u>USDAFoods@azed.gov</u> or calling 602-542-8729.
- To receive Direct Delivery material shipments from Shamrock Foods, SFAs must first submit a valid Purchase Order or Letter of Responsibility to Shamrock Foods for delivery fees published in <u>2025-2026 USDA Foods in Schools Program Administrative Fee Structure</u>.
- All catering sites are being verified with approved CNPWeb applications and will remain in unapproved status pending verification. If you are contracting with a caterer and having foods delivered to the caterer, please email <u>USDAFoods@azed.gov</u>.

### USDA Foods in SY 2025-2026

#### **ADMINISTRATIVE FEE STRUCTURE**

The <u>USDA Foods in Schools Program Administrative Fee Structure</u> is effective July 1, 2025- June 30, 2026.

For USDA Foods Direct Delivery materials delivered by Shamrock Foods, the fee structure is:

- Prep Site delivery \$6.64 per case (20-case minimum)
- Warehouse delivery \$6.39 per case (100-case minimum)
- Pick Up \$4.14 per case (100-case minimum)
- Restocking fee \$1.50 per case

Additionally, ADE assesses administrative fees for the following:

- Processing bulk product \$0.02 per pound
- Excess storage \$1.50 per case
- Direct shipments from USDA \$0.25 per case



### Processing Diversion

#### **BULK POUNDS**

SY 25-26 bulk foods have been diverted to the processors specified in the Processing Surveys within myFOODS. SFAs are required to monitor pound usage via the processor designated websites:

- K12 Foodservice (<a href="https://www.k12foodservice.com">https://www.k12foodservice.com</a>)
- ProcessorLink (<a href="https://www.processorlink.com">https://www.processorlink.com</a>)
- Nardone Bros. via in-house sales contact (<u>Contact</u> <u>Nardone Bros</u>)

SFAs with carryover from SY 24-25 will be contacted directly to submit plans for use. SFAs can elect to relinquish carryover pounds to the State general account for redistribution.



# DoD Fresh Fruit & Vegetable Program

#### YOUR ENTITLEMENT IS READY FOR USE!

Funds set aside during the catalog requisition period are in the FFAVORS system for immediate use in the CNPs.

- For SFAs currently operating SFSP, additional funds are available right now by selecting the Summer Budget.
- FFAVORS funds will be available for SFSP until September 30th or until funds are used, whichever comes first
- FFAVORS funds for SY26 NSLP are available for use beginning July 1st.

### Paid Lunch Equity Tool

#### USDA Released the PLE Tool for SFAs that are not exempt from the PLE Requirements

#### **Not Exempt**

SFAs that do not qualify for the PLE exemption due to a **negative balance** in the nonprofit school food service account as of June 30, 2024, **must follow PLE requirements** when establishing their paid lunch prices for SY 2025-2026.

#### **Using the PLE Tool**

Once the tool is open, Instructions and Calculation sheets can be found on the bottom tabs. Please follow the instructions carefully to ensure the calculations are correct and will meet regulatory requirements.





#### **OPTIONAL TOOL FOR EXEMPT SFAS**

While not required, exempt SFAs may choose to use <u>USDA's PLE tool</u> to complete the steps necessary to determine their target SY 25-26 paid lunch price and adjust their paid lunch prices accordingly.

### Paid Lunch Equity

#### **GUIDANCE FOR SY 2025-2026 PAID LUNCH PRICING**

- SFAs may use the prices they last charged students as the basis for their SY 2025-2026 paid lunch price calculation, even if those prices were charged during a year the SFA was not required to comply with PLE requirements.
- If an SFA did not charge for meals during SY 2024-2025, such as an SFA that operated the Community Eligibility Provision, or Provisions 2 or 3 and is returning to standard counting and claiming in SY 2025-2026, they may use the most recent paid lunch price data as the basis for its SY 2025-2026 paid lunch calculation.
- SFAs are not required to raise their paid lunch price by more than 10 cents for SY 2025-2026 from the last year they charged for paid lunches. SFAs can still choose to raise the price by more than **10 cents.**

SFAs must show a zero or positive balance in their non-profit food service account to be exempt from PLE requirements this year. This can be shown with the Annual Financial Report (AFR).



### SUN Bucks Final Reminders

#### **BENEFIT ISSUANCE**

Households with SUN Bucks eligible children will receive an EBT card with \$120 total for purchasing groceries in the summer months. Households on an active SNAP/TANF case will receive funds on their current EBT card. Benefits distribution has begun.

Funds are subject to expungement at four months (122 days) after benefits are made available.


### **SUN Bucks Eligibility Screener Guide:**

- Most eligible students will qualify automatically and will not need to fill out a SUN Bucks application.
- Families of students that did not qualify automatically but believe they are eligible must use the SUN Bucks Eligibility Screener before
   August 5, 2025 to determine if their child is eligible to apply for SUN Bucks benefits.
  - If the screener determines that the child is eligible, the link to the SUN Bucks application will be provided in the Screener.







### **July Checklist**

#### **July 1 - July 10**

Submit June reimbursement claims (best practice)

#### **July 30**

May 60-day claiming deadline

#### No Sooner than July 1

- Send out Public Media Release.
- Conduct first direct certification through CNP Direct Certification, send notification letters and update BID.
- Distribute household applications with parent letter to only those students who are not directly certified.
- Begin processing household applications with Income Eligibility Guidelines for the current SY, create BID, and send notification letters.
- Send a request to the local health department for 2 food safety inspections to be conducted at all operating sites during the school year.
- Confirm delivery site, contact information, food service director, program contact and billing contact in myFOODS.

### This month...

Submit CNPWeb Site and Sponsor Applications

#### **Prior to School Starting**

- Provide outreach to households for SBP at the beginning of school and at least once again during the school year (required only if operating SBP).
- Print <u>Training Curriculum & Brochure</u> and create Professional Standards plans for all School Nutrition Program Staff, including mandatory Civil Rights training.
- Post point of service (POS) meal signage.
- Train Offer vs. Serve (OVS) to all staff, if applicable.
- Review proper procedures for all procurement methods (micro, small and formal) before making purchases.
- Print out NSLP At a Glance Calendar

#### **After the First Day of School**

- Complete Production Records daily.
- Count meals at POS.
- Complete Daily Edit Checks.
