Re: October 1 Enrollment Data for Fiscal Year 2027

What Is October 1 Enrollment Data?

To ensure compliance with federal reporting and program requirements for the fiscal year (FY) 2027, the Arizona Department of Education (ADE) is compiling data for students enrolled on October 1, 2026. Arizona Education Data Standards (AzEDS) Reports populates data that Arizona school districts, charter schools, and public education agencies (PEAs) [organizations] submit via their respective student information systems (SIS) to ADE and has passed integrity in AzEDS accordingly.

Student-level enrollment, attendance, and program data at educational sites reported by organizations are crucial to accurate funding and determinations for all education programs. ADE uses October 1 data to manage eligibility and funding for limited federal dollars, to comply with federal reporting requirements, and to serve as the basis for general population statistics about Arizona schools.

ADE uses October 1 data for internal and external accountability reports, such as the statewide dropout rate, and to identify students in certain subgroups. Therefore, schools must review and, if applicable, correct this data as soon as possible so that ADE can produce accurate numbers for federal reporting, reconciliation of federal allocations, and preparation of preliminary allocations for FY 2028.

What Are the Important Deadlines?

The final October 1 enrollment data deadline is Wednesday, December 9, 2026. ADE requires organizations to review and correct data submissions if there are inaccuracies. ADE encourages organizations to contact their relevant ADE program area staff for support.

What Are the Consequences of Not Submitting Accurate, Valid, and Timely October 1 Enrollment Data?

ADE shall not include any information submitted after 5:00 PM on December 9, 2026, into AzEDS on the relevant grants or reports indicated in the chart below. Incomplete, inaccurate, or late reporting from PEAs will result in the delay of state and/or federal funds, potential reductions of federal grant funding, and other program enforcement as relevant.
