Since students enrolled at the school are not attending in a school building, students do NOT need to report that they are positive or have been exposed to COVID-19. In the case of Student/Family events:

If a student or family member is sick and/or has COVID like symptoms, please stay home/do not attend events and contact the school for further guidance.

Students participating in in-person events will report a positive COVID-19 case OR exposure to a positive person by contacting the school principal.

Employees who work at the school office should report a positive COVID-19 test or exposure to your principal and/or your school's contact tracer.

If someone in your household has COVID like symptoms and/or has received a positive COVID19 test, employees may still work virtually, but please DO NOT report to in-person activities. Likewise, do not report to in-person activities if you or someone in your household is waiting for COVID test results.
