-If you're COVID positive, isolate from others for 5 days after the onset of symptoms. If you test positive but are symptom free, isolate for 5 days after positive test.

\*As long as you are symptom free or your symptoms have been improving and you are fever free for greater than 24 hours (without use of fever reducing medication) you may leave isolation after 5 days.

\*HOWEVER you must continue to wear a mask for a 5 additional days.

-When to Quarantine:

\*Known exposure to COVID positive person for greater than 15 min in a 24 hour day, and it has been more than 6 months post mRNA vaccine series

(Moderna or Pfizer) or greater than 2 months or receiving Janssen, you should

quarantine for 5 days post exposure.\*If you are fully vaccinated and have been boosted, no quarantine is necessary as long as you remain symptom free.

#### 27. How will the LEA ensure Continuity of Services?\*

Briefly describe an overview of the continuity of services and in the following questions you will provide more detailed information.

Ash Fork will provide in person brick and mortar schools going forward. In the case of a mandated, long-term school closure, Ash Fork Schools having a 1:1 student Chromebook program and the requisite connectivity through T-Mobile for internet access, ZOOM for class meetings, and Google Classrooms for assignments.

#### 28. How will the LEA ensure continuity of services for students' academic needs?\*

All students will be provided individualized small group instruction for any days missed. These students will be allowed to makeup instruction on Fridays from 8-12:00. The student will receive an "exemption" in the grade book for any assignments missed while quarantined. The student will be given opportunities for learning and assignments to be made-up, but can be given a zero if the student does not take advantage of makeup opportunities. We have a 1:1 student/Chromebook ratio and utilize Google Classrooms, Achieve 3000, Lexia, and Math IXL to name a few that offer online lesson communication between teacher and student.

# 29. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?\*

We leveraged ESSER funding to be able to hire a fulltime Counselor/Psychologist that is available to all schools. Focused on coordinating SEL efforts with all teachers to increase social emotional language, skills and strategies that provide sustained lessons and tiered support to students, staff and families. The First Year SC/SW grant has been approved through ADE and GME. This will allow continuing this position once ESSER funds are exhausted.

#### 30. How will the LEA ensure continuity of services for students' other needs?\*
