School will hold in-person learning whenever possible in conjunction with state and federal requirements. If students are required to remain home, academic program will be continued online through Schoology learning platform for the upper grades and packets sent home for primary grades. Each teacher will make personal contact through phone calls, online meetings at least once per week with each student.

21. How will the LEA ensure continuity of services for students' academic needs?*

Academic needs are being tracked through formative assessments, benchmark assessments, and classroom assessments. Students who are not meeting academic proficiency will be given opportunities to attend additional school sessions on Friday or after school. District will also hold an all-inclusive summer school for students to work of academic attainment of state standards. Teachers meet weekly to review data and create re-teach/enrich plans for student groups.

22. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?*

District is currently meeting the social, emotional, and mental health needs of its students through on campus counseling services. If students are required to go to home bound, counselors will conduct mental health checks and coordinate services when needed. District is implementing the Positive Action Social Emotional curriculum K-12 to encourage open discussions and build social emotional health.

23. How will the LEA ensure continuity of services for students' other needs?*

This may include student health and food services.

LEA offers breakfast and lunch through the National School Lunch Program. If in-person learning is shut down, those services will continue through the shutdown.

24. How will the LEA ensure continuity of services for staff's social, emotional, and mental health needs?*

School counselors work closely with staff at both of our campuses to assist them in working with troubled students as well as checking in on their own social emotional health. Positive Action lessons help reinforce mental health in staff members as well as students.

Paid COVID leave was authorized for staff members who were ill or caring for an ill dependent.

District discussed this plan extensively with staff and community prior to its implementation through Back to School Night with parents and staff meetings. Parents also give input through the enrollment process. Our community is overwhelmingly opposed to mask mandates and supports in-person learning. The Governing Board has chosen to open schools to in-person learning, enforce health and safety protocols, and allow any students who prefer to wear a mask to do so in a positive school climate.
