The LEA will ensure continuity of services through ongoing School Board review of ESSER III spending and will determine need for ongoing funding based upon needs and monies available after the ESSER III grant monies have been spent.

Instruction is provided in a teacher-led, in-person classroom for all students Monday-Thursday through the school's adopted fiscal year 2023-2024 calendar. When students are not able to attend due to quarantine/COVID-19 related illness, they can complete work through online learning and submit assignments via the school's virtual platform. All students taught by a certified teacher through daily lessons via the Microsoft Teams platform or Google Classroom platform. Additional Title and Unique Population services provided through online platform when need is identified. Counseling support is also offered online when need is identified.

29. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?*

The school district uses the adopted SEL curriculum, Second Steps for all students. Counselors for students/staff/families are available as need is identified. Multiple breaks are offered through the school day and staff are available as needed to support SEL concerns.

30. How will the LEA ensure continuity of services for students' other needs?*

Donations of food by local charity organizations go to assist families with identified needs. Food available on-site for pick-up if needed and/or delivered based upon individual circumstances.

Second Steps Curriculum incorporates strategies to cope with stress and maintain health. Staff health and wellness program is implemented with support through the school's insurance carrier. Counselors are provided for staff support as need is identified. Counseling through a phone hotline is also provided and telehealth services for all staff.
