Destiny School has a close working relationship with the local health department. We will continue to be transparent with our interactions and reports.

### **Continuity of Services**

#### 27. How will the LEA ensure Continuity of Services?\*

Briefly describe an overview of the continuity of services and in the following questions you will provide more detailed information.

Meeting the diverse needs of our students remains our focus. We will continue to be vigilant in our efforts of education our student in a safe and effective manner. To achieve this we have purchased 2 additional buses to create 2 more routes and this allows us to reduce the amount of students on the bus to maintain social distancing. Transportation is made available to all students. We have upgraded the schools network to fiberoptic and purchased Additional chrome books and hot spots for students to facilitate remote instruction for the students to take home when they are quarantined or have to miss other extended periods of attendance. We have maintained and will continue to maintain all Special Educational services including but not limited to Speech Therapy, Occupational and Physical Therapy.

#### 28. How will the LEA ensure continuity of services for students' academic needs?\*

Each student's academic needs remain individual to them. We will address any needs or concerns on that individual level. We have various platforms in which to accomplish this. To address the academic needs of students we provide 50 minutes of small group structured literacy instruction to all students who score at risk or some risk on the school's universal literacy screening program for K-5 grades. All students who have failed to achieve a passing grade on formative assessments in math or ELA are placed in a re-teach/re-test period until they pass the formative. Additionally, the school has implemented an online literacy intervention from MindPlay.com for all students who score below grade level on reading summative assessments for 30 minutes a day. The school also provides afterschool tutoring, Friday tutoring and summer school for students that are struggling. The Special Education department provides instruction in related services to each Special Education student in accordance with the students Individual Education Plan. Professional Development for Teachers is ongoing in the areas of phonics, reading intervention, affective classroom accommodations and modifications, use of technology in the classroom and data driven instruction.

We will be using some of our ESSER funds to contract with a SEL social worker to help mitigate any further effects. We are also using a research based SEL platform (CASEL) to help identify any specific student issues. We also refer students to the two local counseling serviced that deal specifically with emotional, mental health issues.

Student well-being remains paramount and we will continue to provide any supports necessary to ensure that our students remain healthy. Destiny School has built its own kitchen and upgraded its cafeteria in an effort to provide quality meals to every student.
