Teachers and staff members will and will encourage students to:

- Wash hands often for at least 20 seconds.
- Cough and sneeze into the elbow.
- Dispose of tissues and paper towels appropriately.
- Monitor for any symptoms that would indicate possible Covid-19 or other illness.
- Hand sanitizer will be available in all classrooms and interaction points such as the front office area.
- Use of sanitizer will be encouraged when transitioning from activity to classroom to include lunch, recess, bathroom breaks.
- Students will use water stations to refill water bottles during breaks and lunch period. Drinking fountains will not be available for use.

• Front office and other high traffic areas will be cleaned and disinfected throughout the school day.

Classrooms will be sprayed with disinfectant every two weeks.

In accordance with CDC recommendations:

- If less than 24 hours have passed since the person who is sick or diagnosed with COVID-19 has been in the space, Edkey maintenance team will clean and disinfect the space.
- If more than 24 hours have passed since the person who is sick or diagnosed with COVID-19 has been in the space, Edkey maintenance team will clean the space.
- If more than 3 days have passed since the person who is sick or diagnosed with COVID-19 has been in the space, no additional cleaning (beyond regular cleaning practices) is needed.

Food Services

Meals are provided to students attending school. In the event of a return to distance learning meals can be picked up at the school by parents.

In-person learning will be similar to classroom instruction prior to school closures to COVID. This includes whole group and small group instruction. Intervention will be provided to students to address learning gaps due to lost instructional time.

Instructional resources include digital components that allow students to access lesson material from home in the event a student our classroom is guarantined.

Teachers use Google Classroom for communication, instruction, and assignments for individual student and whole classroom instruction in the event a student or classroom is guarantined
