EESD will continue to follow all guidelines to promote a safe and healthy environment for our student. We will continue to follow our curriculum maps and ensure all students education needs are met. Our bell schedules will continue.

#### 21. How will the LEA ensure continuity of services for students' academic needs?\*

EESD will continue to provide a quality education for our students. We have curriculum maps for all grade levels. Students are screened within 45 days of enrollment to identify any needs in academics, communication, social emotional development, and physical development. Students with needs are referred to student study team and possibly to special education department for further evaluation. All students are screened using a variety of screeners to ensure that they are making progress. Students identified as not making progress are given muti tier interventions to address needs.

# 22. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?\*

EESD has a full time Counselor and uses local agencies to assist student emotionally and mentally. Students with needs that are impacting there educational abilities are identified and may be referred to special education department for further evaluation and or to help create a behavioral plan if warranted.

#### 23. How will the LEA ensure continuity of services for students' other needs?\*

EESD will continue it practice to address the need of all individuals by reviewing Individual Education Plan (IEP's). All students are screened regularly to determine if there are any needs academically or emotionally. The staff will work together to provide interventions services to meet those needs.

EESD have service through our insurance provider to support our staff emotional and mental health challenges. New teachers are assigned a mentor teacher to help support them during the first year. Teacher's are encouraged to ask for help at anytime.

EESD has an open door policy where staff can feel safe to address any personal needs. We will continue our practice.
