FTUSD has followed all mask mandates and social distancing requirements for public events per county and tribal requirements. We have collaborated with our local health departments' recommendations (Graham County and San Carlos Apache Tribe).

#### 21. How will the LEA ensure Continuity of Services?\*

Briefly describe an overview of the continuity of services and in the following questions you will provide more detailed information.

FTUSD has been full in-person since August 4, 2021 and we plan to stay in-person unless forced by state or local health departments. FTUSD operates in Graham County as we choose to operate within the state and health guidelines and to consider San Carlos Apache Tribe health guidelines. When students have been in quarantine, we have provided them with resources such as Chromebook or paper/pencil work to be completed at home. Our teachers are prepared to offer online support for students that are required to be at home as well as offer in-person instruction.

#### 22. How will the LEA ensure continuity of services for students' academic needs?\*

All schools are required to ensure teachers maintain a Google Classroom site where all assignments are posted and available for students whether they are in-person or at home. Any student remaining at home for COVID related reasons such as a positive test, has the ability to engage with course work and complete assignments on time and pace. Virtual meetings are made available for students through Google Meets for in-classroom engagement or follow-up tutoring support.

FTUSD offers after-school remediation to support all students' learning needs.

FTUSD plans to incorporated summer school for Summer 2023 for students K – 12 and are planning on subsequent summer school years.

### 23. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?\*

We have increased staffing to include 2 social emotional counselors/social workers to support all students K – 12 and families.

#### 24. How will the LEA ensure continuity of services for students' other needs?\*

Our food services provided meals during the summer – breakfast and lunch for all children 18 years and younger.

We were able to provide staff with a stipend for continued employment for this school year.
