Certified staff throughout the school district received SEL training and are implementing SEL in the classroom. Staff continue to receive mental health support from Jorgensens Brooks.

Ganado USD is providing In-Person learning for all students from Pre-K through 12th grade. Schools are providing students with intervention services to improve their academic needs.

Students have access to school counselors to assist them with their social emotional and mental health needs. They also have support within their classrooms through social-emotional learning.
