Students at School Upon arrival at school, each student will proceed directly to the student's first period classroom. •Prior to entering classroom, teacher will visually check each student. Any student with visible symptoms of runny nose, cough, shortness of breath, vomiting will be directed to Health Office where parent will be contacted to pick student up with the following exceptions: •If the student has a runny nose and no other observable symptoms, the Health Aide will contact parent to determine if other symptoms are present or if there is exposure to COVID-19 in the home. If not, student may return to class. •If student has health information that confirms a diagnosis of asthma or other respiratory condition, the Health Aide, will contact parent to confirm that the student has no other symptoms or exposure to COVID-19 at home. If not, student may return to class. Teachers and Staff MHP employees will not be permitted to work on-site if they exhibit any of the following symptoms: •fever of 100.4 degrees or higher, or chills; •shortness of breath or difficulty breathing; •muscle aches; •sore throat; •headache; •fatigue; •congestion or runny nose; •cough; •nausea/vomiting; •diarrhea; or •new loss of taste or smell. *This list may not include all possible symptoms. CDC will continue to update this list as more is learned about COVID-19. Additionally: Each MHP teacher and staff member will take his/her temperature, if feasible, at home and assess whether or not she/he is experiencing any of the stated COVID-19 symptoms prior to arriving at work. All students and families, including those with disabilities, will be provided technology training for distance learning. Additionally, technology support for students and families, including those with disabilities, will be provided to address any issues encountered in relation to the academic program and use of technology throughout the school year. Students with disabilities will participate in daily classroom instruction for 4 periods of 90 minutes. Students with disabilities will be provided assistance during daily classroom instruction by special education teacher and/or special education para-professional in accordance with IEP needs and goals, for 4 periods of 90 minutes. No additional processes will be required to provide students with disabilities the students services necessary to meet their IEP needs and goals.

The Centers for Disease Control and Prevention (CDC) have updated their guidance to safely operate schools. The CDC states: Schools are an important part of the infrastructure of communities. They provide safe and supportive learning environments for students that support social and emotional development, provide access to critical services, and improve life outcomes. They also employ people, and enable parents, guardians, and caregivers to work. Though COVID-19 outbreaks have occurred in school settings, multiple studies have shown that transmission rates within school settings, when multiple prevention strategies are in place, are typically lower than – or similar to – community transmission levels. CDC's science brief on Transmission of SARS-CoV-2 in K-12 Schools and Early Care and Education Programs summarizes evidence on COVID-19 among children and adolescents and what is known about preventing transmission in schools and Early Care and Education programs. Schools should work with local public health officials, consistent with applicable laws and regulations, including those related to privacy, to determine the prevention strategies needed in their area by monitoring levels of community transmission (i.e., low, moderate, substantial, or high) and local vaccine coverage, and use of screening testing to detect cases in K-12 schools. CDC continues to recommend masking and physical distancing as key prevention strategies. However, if school administrators decide to remove any of the prevention strategies for their school based on local conditions, they should remove them one at a time and monitor closely (with adequate testing through the school and/or community) for any increases in COVID-19 cases.
