While Horizon Honors has the ability to switch to hybrid or remote learning, we have made the commitment to our students, families, and staff to remain in person for the 2022-2023 school year and beyond. Should Maricopa County Department of Public Health determine we need to transition to a different mode of instruction, we would abide by that and make the change to provide continuity of services to all students as we did during the 2020-2021 school year

24. How will the LEA ensure continuity of services for students' academic needs?*

Teachers were trained prior to the school year on instructional strategies to identify gaps in instruction and how to effective close the gaps for student's individual learning loss, while continuing the pace of instruction needed for course completion. In each student's schedule they have at least one block of a scholastic lab (every other day) which focuses on work completion and support in course content. Three times a week, students have the option to attend student support for one hour after school for individual help on their classes.

We have hired a Dean of Student Academic Interventions to support individualized intervention for students who exhibit learning loss. This individualized support will provide additional tutoring through partnering with a third party vendor to provide virtual tutoring both inside and outside of the school day.

25. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?*

Horizon Honors has hired an additional student advisor to assist in students social, emotional and mental health needs. Communication between teachers, health office staff, and counselors is emphasized to support students who may be struggling to readjust to the school environment. Horizon Honors has an SRO for additional student support in classroom instruction and 1:1 support for any needs that he is able to support.

Our wellness committee, Healthy Horizons, has worked on bringing wellness classes back to campus that includes, yoga, pickle ball, book clubs and special occasion celebrations. The administration asks for staff input on improvements to the work environment and we have a structure of support with instructional coaches to support teachers 1:1 on a regular basis. We have an Employee Assistance Plan through our insurance provider and have communicated Arizona Department of Education's Educator Peer Support Program for teachers.

We sent out a survey at the end of the 2020-2021 school year to help guide our decisions for the 2021-2022 school year. We provided an opportunity for parent input in February 2022 on the use of ESSER III funds via the website and parent/guardian communication.
