In the event of a school closure, academics will be delivered via our web-based Learning Management System coupled with learning opportunities via Zoom, Google Hangouts, etc. Special Education Services will continue via online meetings (Zoom, Hangouts, etc.) as well as through the Learning Management System.

Our scholars can attend school in-person at our brick-and-mortar campuses or attend our virtual academy. We have reading and math intervention programs in place to assist scholars identified as needing assistance through a universal screening process.

We have added a school counselor or social worker to our schools. These individuals will assist families by providing community resources, when appropriate, as well as counsel scholars with personal and psychological issues that affect their performance, behavior, and socialization in school.

Staff members have been offered various trainings on social emotional related topics. We have an employee assistance program through our health benefits provider and that information has also been provided to staff members.
