The County Health Department works closely with the district to ensure appropriate guidance is available, testing materials and masks are available, and holding vaccination clinics.

The district has partnered with ASU Social Services to provide counseling to students and staff. One of the local mines is also offering wellness programs for staff. Clothing needs are met working with Kid's Closet. Academics are able to continue for students via Zoom, Canvas, and Seesaw. Communication between parents and teachers are held regularly and the district posts and sends via email and phone information quickly.

26. How will the LEA ensure continuity of services for students' academic needs?*

Should a student become quarantined, academics are offered via Zoom and on Canvas and Seesaw in order to continue their education.

27. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?*

The district has partnered with ASU Social Services department to provide counseling services. The district has also hired a counselor for grades 6-12 students.

28. How will the LEA ensure continuity of services for students' other needs?*

This may include student health and food services.

Each school has emergency provisions for clothing and food. Clothing is provided bi-annually and on an emergency basis by Kid's Closet.

Other needs are identified and addressed on a 1:1 basis.

29. How will the LEA ensure continuity of services for staff's social, emotional, and mental health needs?*

The district has hired a counselor to work with grade 6-12 students and partnered with ASU Social Services Department to provide counseling to all students and staff as needed.

30. How will the LEA ensure continuity of services for staff's other needs?*

The district uses the assigned SRO for immediate safety needs for students and staff members. Other needs are addressed on a 1:1 basis.
