Parent and student surveys were sent home in Feb 2021 to address the success and future needs of a safe return to in-person instruction. Student input was also taken through student council meetings in the junior high grades. A public meeting (and school board meeting) was held on August 2, 2021 to seek public input on the proposed mitigation plan for the return to school and the discussion of requiring masks on buses. Discussions with MVS staff took place at various meetings in June and July to discuss mitigation strategies and a safe return to in-person instruction for the 21-22 school year.
