Ensuring continuity of quality instruction for our students is one of our top priorities. For the 2023-24 school year all school sites will be open for in-person instruction to ensure continuity of services.

28. How will the LEA ensure continuity of services for students' academic needs?*

Murphy will provide academic intervention services to students in a variety of ways. Additional instructional staff will be added to reduce class sizes and to providing more focused attention for students. Also, each campus will have a targeted reading intervention program. Each campus will also have an after school program. In addition to the targeted intervention and after school program, the district will run a summer school program, including transportation. Each of the programs mentioned will provide support to those most impacted by COVID.

29. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?*

School counselors have been hired for each campus to further support the social emotional and mental health needs of students. Additionally, to provide a well-rounded learning experience that supports the social emotional growth of students, special area teachers, art and technology, will be hired to ensure each campus is able to offer these courses. Students will also be provided with after school sports and clubs to provide additional opportunities for social emotional growth.

30. How will the LEA ensure continuity of services for students' other needs?*

This may include student health and food services.

All students in the Murphy Elementary District are automatically eligible to receive free meals.

The health and wellness of Murphy staff members will be supported through the availability of Behavioral Health Employee Assistance program sessions at no cost. The Employee Assistance Plan (EAP) is a professional service which provides confidential assessment, referral and short-term counseling services to employees for behavioral health issues.
