Air flow and ventilation systems were enhanced in FY21. This included installation of UV lights and additional HEPA filters in air vents. New ventilation was installed to increase air flow. Stand alone HEPA air filter units have been installed in all classrooms and offices. All high use

areas are consistently cleaned and sanitized.
