The Arizona legislature recently passed HB 2898 and one of the amendments states that schools are no longer allowed to require masks. However, the Navajo Nation still requires masks in public places based on a recent public health order and our parents have asked us to be extra cautious. Out of respect for the Navajo Nation and the majority of our students and their families who live on the reservation, our mask policy states "masks are strongly recommended for anyone who is in a vehicle (including buses) or indoors and in a room with other people while at STAR School." Even though we are not mandating masks, we consistently have had all of our staff, students and visitors complying with our recommendation to wear a mask.

At STAR School we have adequate facilities for social distancing to comply with the CDC guidelines of 3 feet between individuals. We are also using cohorting strategies to keep groups of students separated as much as possible. On the buses, students are grouped together with siblings and every effort is made to to leave empty seats between the family groups when possible. At school, students' interactions with other students outside of their homeroom class is extremely limited. Students have classes, meals and recess time with the same group of students each day. This strategy allows for reduced spread of the virus and easier contact tracing.

All individuals on campus will be required to follow handwashing procedures upon arrival and throughout the day. Students and staff will be required to wash their hands with soap and water for at least 20 seconds (or use hand sanitizer with at least 60% alcohol when soap and water are not available) at the times listed below: • upon arrival at school (use hand sanitizer if there is no sink in the classroom) • after being outside for physical activity between interacting with different groups of people (i.e. teaching different			
groups of students) • after using the restroom

Students and staff will be trained in how to wash hands effectively, and signs will be posted as reminders. Hand sanitizer stations will be available throughout the school at various

Prior to returning to in person instruction, we hired a full-time, onsite custodian for our school. In the past we have used outside cleaning services, but having a dedicated person on site is preferred. We have made several improvements to our HVAC systems. We have forced air HVAC systems in some of our buildings, and in these we installed hospital grade HEPA filters. Many of our buildings have radiant floor heating systems, so in these we are using portable HEPA air purifiers. We also upgraded the HVAC system in our kitchen to ensure the highest level of safety for our staff and students.

We work closely with the Coconino County Health and Human Services (CCHHS) when we have an exposure or positive test at our school. They have a dedicated school liaison who provides guidance around isolation, quarantine and contact tracing. We attend regular briefings every two weeks with CCHHS and other schools in the area and also receive weekly school health reports prepared by CCHHS that we use to inform COVID-related decisions at STAR School. We also attend regular biweekly meetings with the Winslow Indian Health Care Center (WIHCC) and other schools who serve Native American students to understand the COVID situation on the Navajo Nation.

Our school participates in weekly pooled COVID testing, which is provided by Concentric using a PCR method. We test our students and staff every Thursday in pooled groups that range in size from 8 to 24 individuals. Concentric coordinates for a licensed nurse to come to our school campus and conduct the testing in partnership with our school administration. We currently have 97% of our staff and 92% of our students participate in the pooled testing program. In the event of a positive pooled test, the nurse helps us conduct individual follow up tests using the BinaxNOW rapid antigen tests. After the individual(s) who tested positive are identified, we coordinate with CCHHS regarding isolation, quarantine and classroom closures.

Because STAR School serves students from kindergarten through 8th grade, the majority of our students are currently not eligible for vaccination because they are under 12 years of age. Therefore, it does not make sense for us to host a student vaccination clinic at our school. There are a number of vaccination opportunities for students, staff and other community members through WIHCC on the reservation and CCHHS in other areas. We have provided our staff with information on where they can find these vaccination clinics.

We will work with students and families to accommodate any reasonable request for students with disabilities. For example, we have a student with special needs who has opted out of COVID testing because it is triggering for him and caused a traumatic reaction. Should other specific accommodations be required in the future, our administration will consider them.

As previously mentioned, our school works closely with our county health department, CCHHS, for many aspects of COVID in our school. We also receive regular updates from the Arizona Department of Education related to COVID.
