Pensar Academy has contracted for janitorial services that include disinfectant fogging and cleaning of shared surfaces campus wide.

Pensar Academy has installed improved ventilation systems throughout the campus to increase ventilation, including a new filtration

system for Science Lab classroom.

Pensar Academy reports COVID positive stakeholders to the appropriate reporting agencies as outlined by Maricopa County,

Arizona Department of Health Services, and CDC and notifies according to the guidelines those in close contact with positive persons. Infected persons are given the 5-day parameter for isolation, with the additional 5-day parameter for modified quarantine parameters offered by the CDC. Close contact persons are given the symptom checklist by the CDC to monitor for symptoms of the illness.

Screening: Pensar Academy utilizes daily temperature checks at the door. Students exhibiting symptoms are isolated and parents

are contacted. In the event a staff member exhibits symptoms, he/she/they are instructed to get tested immediately. All staff members

have been trained on looking for the indicators of COVID to assist in early identification of all stakeholders who exhibit symptoms.

Diagnostic: For positive test results, all stakeholders submit a positive lab test result for reporting purposes to the Maricopa County

Health Department. Pensar Academy is in the process of securing Rapid Tests. Persons are notified as outlined by the Maricopa County

Health Department.

The Pensar Academy community has come together to create this plan based upon the recommendations of all stakeholders and with the guidance of the state and federal regulatory agencies to create a reopening plan that is flexible, comprehensive, and puts best practices into action for the safety of our staff, families, and students. The COVID pandemic has challenged our community to think outside the box, pivot from the familiar, and adjust our way of life...requiring more than ever for our society to communicate, collaborate, critically think, and come up with creative solutions.

Staff, students, and families were surveyed to determine strategies that ensured academic rigor and growth, as well as care for the personal safety of all involved in the formulation of this plan. Governmental agencies have provided the necessary support to ensure that we can deliver instruction, have our classrooms ready for student return, and come up with a plan for when it is safe to get back to in-person learning.

27. How will the LEA ensure continuity of services for students' academic needs?*

- Addition of a Speech and Writing Class to address gaps in writing and language widened by modified instruction during school closures for COVID19.
- Addition of targeted ELA and Math blocks to address gaps in writing and language widened by modified instruction during school closures for COVID19.
- Expansion of School Library resources to include additional books at varied reading levels and Kindle Readers through

the ECF to provide materials for extended practice to recoup skills lost during school closures due to COVID19.

- Provision of Project Based Learning Units coached meticulously by staff for students to learn to collaborate, communicate, critically think, and utilize creativity.
- The Principal, Assistant Principal, and STEM Director cover classrooms where there is a teacher shortage to ensue seamless delivery of quality instruction.

• Providing adequate time in structured and socially distanced environments for students to socialize with one another.

(Student Advisory breakfast seating in the gym, modified recess activities, modified lunch seating)

- Wednesday Youth Development Program funded through 21st CCLC.
- After School Clubs and Activities that promote wellness such as Running Club, Cooking Class, and Yoga funded through

21st CCLC.

- Providing social skills lessons through Student Advisory.
- Providing a student mediation program.
- Providing modified student activities and clubs in a safe manner. (Harvest Festival, BARK Program, Sports Program, et. al)
- Providing resource contacts and posting information for Suicide Helplines.
- Providing a School Point of Contact for students and parents to access with concerns along with dedicated phone line.
- The addition of a Specials class called "Human sySTEMs" in which stress management, health and wellness are taught

twice a week.

29. How will the LEA ensure continuity of services for students' other needs?*

This may include student health and food services.

- Provision of school uniforms and sweatshirts as needed for students
- Provision of a Parent Liaison.
- Partnership with St. Mary's Food Bank to provide food bags for families.
- Partnership with a non-profit to provide eyeglasses for identified students.
- Provision of additional learning time outside of school hours with the BARK Program morning and evening hours, Open

Gym, and Parent Drop off Saturday funded through 21stCCLC.

• Provision of a staff that is CPR and First Aid certified.

- Provision of mental health counseling services with the insurance plan.
- Provision of a professional mediation service to assist in employee working relationships.
- Provision of staff culture building events (Boot Camp, Escape Room, Thanksgiving Dinner).

- Provision of Professional Development in Effective Communication, Cultural Diversity Training, and Crisis Prevention Training.
