Teachers will work in conjunction with administration to ensure students are receiving teaching and learning specific to student needs. When teachers feel a student is struggling with meeting grade level standards, the teacher will refer that student to our Child Study Team to further analyze. Parents will be invited to these meetings. There could be a possibility that the team then refers for the student to be evaluated by the school psychologist for a possible learning disability. The Quartzsite Elementary School District will continue to offer after school tutoring.

The Quartzsite Elementary School District will continue to offer the counseling services to parents of students who are socially, emotionally, or mentally in need of counseling. Teachers will continue to integrate social emotional learning in the classroom on a regular basis.
