We understand that in-person learning is the best thing for our students. We will continue to provide in-person learning for the 2022-2023 school year. For students that are out of school due to COVID-19, we will provide assignments through an online platform and a Chromebook to ensure student success continues during this time. In the event our school needs to have an intermittent school closure due to a high number of cases at the school, we would provide remote learning to all our students during that period of time.

#### 28. How will the LEA ensure continuity of services for students' academic needs?\*

Red Rock Elementary School District assesses our students three times a year through our district assessment, MAP. Teachers and specialists monitor and review the date to ensure learning gaps are being addressed. Teachers implement formative assessments to continue to monitor student academic progress. Red Rock Elementary School provides after school tutoring for students in grades K-8 with

a higher need for academic support. Reading and Math Specialists as well as our Special Education team work to support students with academic needs. All teachers and students have access to online resources in the event any students need to be quarantined. Communication to families continues to be a huge priority for our students' success during this time.

We have a school counselor provide weekly lessons to our students and teachers to support their social, emotional and mental health needs. Our school counselor offers small group and individual support for students that have anxiety after this past year. Many students work in a small group with our counselor to build relationships and relearn working together. Our school nurse offers support to our students both physically and emotionally each day. Our school will reach out to the CRC in the event we have concerns for students struggling with depression and self harm. In addition we also contract with online counseling services that uses Zoom to meet with students. This program is being used throughout schools in Pinal County.
