#### 27. How will the LEA ensure Continuity of Services?\*

Briefly describe an overview of the continuity of services and in the following questions you will provide more detailed information.

SUSD has been full in-person since October 19, 2021 and we plan to stay in-person unless forced by state or local health departments. Safford Unified School District operates in Graham County and as we choose to operate within the state and health guidelines, in a worst case scenario, we would consider having the option of opening in a hybrid model for K-8 if the state health metrics allowed us to do so. Our plan could be to operate an A and B student schedule using students' last names so families can send students in their household on the same days. We would also commit to making changes and accommodations for families that have children with different last names. In this plan, Group A students would come on Mondays, Group B on Tuesdays, Group A on Wednesdays, Group B on Thursdays and each would alternate every other Friday. Teachers would still have instructional plans and expectations for students on their distance learning day and their participation and attendance would still be tracked in the same manner previously followed.

#### 28. How will the LEA ensure continuity of services for students' academic needs?\*

SUSD incorporated 2021 summer school opportunities, and 2022 summer plans. We plan to offer K-3 after school ELA services after school during the school year. Our alternative school, Mount Graham High School meets the needs of 9-12 students using online curriculum with teacher support.

# 29. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?\*

We currently have 2 high school counselors, a Student Support Service Provider for K-6, and have rolled out Capturing Kids Hearts training for all staff.

#### 30. How will the LEA ensure continuity of services for students' other needs?\*

This may include student health and food services.

Our food service provider, Sodexo, currently provides summer breakfast and lunch meals for children under 18 and is applied for and has been granted free meal offerings during the school year for next year.

We have provision built into our sick leave plan for mental illness and our Capturing Kids Hearts training rollout is for staff as well.
