In classrooms, the student desks will be 3 feet apart. Mandatory social distancing has been lifted for indoor events. Social distancing is not required outdoors on playgrounds or on the school bus.

The District will instruct & reinforce handwashing with soap & water for at least 20 seconds. Hand sanitizer that contains at least 60% alcohol will be available in every classroom and room throughout the district including free-standing hand sanitizing stations. Signage/posters will be placed on each campus to educate and encourage preventive practices.

# 16. Please describe the LEA's Governing Board policy on cleaning and maintaining healthy facilities, including improving ventilation.\*

The District has developed a schedule for increased, routine cleaning and disinfection. Door handles, sink handles, and desks shall be

sanitized throughout the day. HVAC filters are changed and are on a maintenance schedule to ensure efficient operation. Increase circulation of outdoor air as much as possible at all school sites and student/staff areas. Buses will be sanitized between morning and afternoon routes and at the end of each day. The district purchased disinfecting/sanitizing portable and industrial machines.

The district used ESSER funding to purchase new HVAC units with built-in HEPA Filtration Systems.

The District's FY 2023 Back to School 12 Point Plan will be presented to all staff, students, and parents. Included in the plan are the forms to report an exposure or COVID-19 illness. The Navajo Tribal Health Guidelines state that an individual experiencing symptoms or receiving a positive test should self-quarantine for 10 days and may return to school when symptom-free, receive a negative COVID-19 test and

follow their physician's orders.

The district provides a 12-point symptom-checker to assist parents in evaluating their student's health – prior to boarding the school bus. Parents have been given digital thermometers to help with the health check. The district's Health Techs will immediately respond to any

student or staff experiencing COVID-19 symptom(s).

All individuals are encouraged to be vaccinated and receive additional boosters for COVID-19 per the Navajo Dept. of Health Services (NDOH). The Navajo Health Clinic provides free COVID-19 vaccines.

In addition to the return to In-Person Instruction Health and Safety procedures and mitigation strategies as approved by the Board; all

appropriate accommodations will be made to ensure that students with disabilities have their specific needs met in regards to health and

safety protocols. These accommodations are provided per each student's IEP. At-risk students may attend distance learning, if requested, home visits may be provided by Sped. Specialists and/or Health Tech for specialized services.

The Superintendent attends all scheduled meetings with the Apache County Health Dept. and the NDOH.

#### 27. How will the LEA ensure Continuity of Services?\*

Briefly describe an overview of the continuity of services and in the following questions you will provide more detailed information.

A student with special health needs may attend the district's AOI online school. The district hired 4 Social, Emotional Counselors for staff and students. Employees have been given a hotline number to reach a certified mental health provider through the district's employee health insurance provider. The district remains diligent in its safety and cleaning protocols and adheres to health regulations adopted by the NDOH. ESSER funds provide a Retention Stipend to all certified and classified staff as an incentive for maintaining student/teacher consistency while retaining well-qualified workers. Staff will receive COVID-19 prevention training as recommended by the Apache County Health Dept. or the NDOH.

#### 28. How will the LEA ensure continuity of services for students' academic needs?\*

Teachers will make every effort to ensure each student has the tools to complete their school work. Parents are encouraged to contact

their student's teacher with learning concerns. The district is providing an extensive summer school program to address the

learning gap and summer slide. Each student received an iPad or Chromebook. Hotspots will be issued to each student's family should we have another COVID-19 closure. Students living remotely without internet access will have learning packets delivered to their homes.

### 29. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?\*

The District hired a Social Emotional Counselor for each school site to provide support to students and staff. The district assists the local chapter houses with the distribution of mental health resources to families.

#### 30. How will the LEA ensure continuity of services for students' other needs?\*

This may include student health and food services.

Daily breakfast & lunch is available to students at the school sites. Families located remotely will pick up their meals at a designated spot closer to their homes. Meals will be transported by school personnel in official vehicles.

# 31. How will the LEA ensure continuity of services for staff's social, emotional, and mental health needs?\*

The district has a social-emotional counselor at each school site to serve staff and students. The District's healthcare provider has online resources; counselors and nurses are available via telephone. All services are free. Teachers receive additional professional development in Response to Intervention (RTI) to increase knowledge and integration of

effective intervention strategies.

#### 32. How will the LEA ensure continuity of services for staff's other needs?\*

The district's custodians, maintenance workers, and bus drivers receive regular training through The Trust to learn best practices in

preventing the spread of COVID-19. The district partnered with the Apache County Health Dept. to set up an immunization center at the district parking lot. Staff may attend professional development delivered virtually so they do not fall behind in their fields, and to ensure they have the tools to succeed at their jobs.

The Mitigation Plan is discussed at the monthly Governing Board Meeting - updates on the virus and preventative measures are presented.

Parents are asked to call the District Office or their child's school with their concerns are suggestions. A Notice to Parents was placed on menus welcoming parents to call the school and review the Safe Return to School Plan on the district's website.
