The school will employ a Campus Dean that will have a focus placed on identifying the social, emotional, and mental health needs of students above and beyond existing ESS/ELL requirements. This will take place through daily visits in classrooms, daily discussions with teachers, and communications with parents. The Dean and School Principal will create strategies to "mentor" these students with the assistance of paraprofessionals and other school staff.
