Providing flexible educational solutions for our students including traditional learning, hybrid learning, outdoor learning, and asynchronous learning.

• Giving additional PTO days to staff members who need to care for family or who have extenuating circumstances as a direct or indirect result of the pandemic.

- Building out customized physical barriers (cubicles) for both students and staff.
- Offering all students free lunches regardless of FRAM Paperwork Status.

• Hiring an additional three para professionals to give students more adults to interact and work with.
