** According to CDC Guidelines, close contact is defined as someone who was within 6 feet (or in the K–12 indoor classroom setting, the close contact definition excludes students who were within 3 to 6 feet of an infected student if both students correctly and consistently wore well-fitting masks the entire time) of an infected person for at least 15 minutes cumulative in a 24 hour period starting from 2 days before illness onset (or, for asymptomatic patients, 2 days prior to specimen collection) until the time the patient is isolated.

• Students deemed to be a close contact and, if symptom free, will be able to attend school with the expectation that they will monitor for symptoms for 14 days after the last exposure date to the COVID positive individual. If COVID-like symptoms develop, the student is expected to stay home from school and follow isolation protocols.
