The school restrooms and classrooms contain sufficient supplies, including hand soap and paper towels in the restrooms, and tissues, hand sanitizer and wipes in the classrooms, accessible by all staff and students. Students and staff are reminded and encouraged to wash their hands with soap and water, or use hand sanitizer:

• use hand sanitizer upon arrival at school,

• wash hands with soap and water or use hand sanitizer or wipes upon returning from outside activities,

• before and after lunch wash hands with soap and water or use hand sanitizer or wipes,

- always cough into the forearm,
- use tissue when sneezing, coughing, or blowing nose,

• wash hands with soap and water or use hand sanitizer after sneezing, coughing, or blowing nose.

The school janitors clean the school facility on a daily basis. Great care and attention is provided to ensure that the effective processes are in place for adequately sanitizing and cleaning the school facility. It is the function of the janitor to clean daily all frequently touched surfaces throughout the building, such as door handles, sink handles, drinking fountains, desks, etc. Additionally, all staff have secure access to cleaner that can be used as needed.

The social emotional needs of students are monitored by classroom teachers who reach out to administration to assist with supporting any student in need.
