This is information you may wish to have about how publications of UNICEF and Amnesty International are one-sided propaganda in favor of Hamas terrorists, which caused antisemitism at an Arizona high school, and you may wish to have them, and their clubs, off your campuses. Copies of the relevant literature are enclosed.

Last week at an Arizona high school, a large number of students attended a lunch time presentation, sponsored by the UNICEF and Amnesty International clubs, which was profoundly antisemitic in particular and anti-American in general, in nature. Jewish students reported feeling unsafe because of the antisemitism among other students generated by these presentations.

The first page of the attached Amnesty International document refers to apartheid, suggesting that Israel is guilty of that. The fact is that Arabs serve in the Israeli legislature, and Arabs serve as judges in Israel. No Arab country has similar tolerance.

The second page suggests that when holocaust survivors purchased land in Palestine, this was done "illegally" - - untrue. It also targets the United States, stating "with support from the USA, Israel took control of Palestine, and subjected its people to unfair laws and human rights violations". When the enemies of the US and Israel chant "death to Israel", they also chant "death to America".

This page also states that "Palestinian have been subject to killings, torture, rape, abuse, and more for over 75 years." This is a "blood libel" similar to the blood libels used in the Middle Ages to get people to go out and kill random Jewish people.

In none of this propaganda is there any reference to what happened on October 7. The fact that 1400 civilians were murdered does not begin to describe to horror of what Hamas did. They went house to house in the neighborhoods, machine gunning entire families, and sometimes killing fathers in front of their children and children in front of their fathers. They copied the Nazi technique of setting fire to houses so that people would burn to death, or if they came out of the fire house, killed them upon their exit. The actions of Hamas are a repetition of what happened during World War II. Yet the materials make no mention of October 7

Their own videos showed women with their hands tied behind their backs, marched through the streets, subject to the violence of angry mobs. CNN noticed that women had blood on their pants, indicating they had been raped.

Marchers for Hamas chant “from the river to the sea”. All of Israel is between the river and the sea. They are not interested in a two-stage solution, which Israel has tried to negotiate several times, but to destroy all the Jewish people who live in Israel, a second holocaust.

We all belong to a minority group of one kind or another. If Jewish people – and Americans in general -- can be targeted by UNICEF and Amnesty International, who is next?

Toward the bottom of the page the intifadas are referred to as “non-violent actions” when we all remember numerous intifada suicide explosions, killing large numbers of innocent people.

On the next page there is another blood libel, stating falsely that “the Israeli army has also physically and emotionally abused many kids...”.

I do not want to make this memorandum too long. You can see further blood libels in the literature that is attached. UNICEF is under the thumb of the United Nations, which is now dominated by authoritarian countries. Iran was just elected the head of human rights for the United Nations! Amnesty international, which was an excellent organization when it started, went hard left many years ago.

Giving aid and comfort to terrorists is contrary to US law. I urge you to consider keeping amnesty international and UNICEF, and their literature, off of your campuses. They generate antisemitism among impressionable young people, as just happened at an Arizona high school.
