Ir U st o e p	CUSD and John Hopkins implemented a pooled testing strategy for screening through a formal, - Safe Return to n-Person Instruction and Continuity of Services Plan (ARP Act) board approved partnership with Johns Hopkins Iniversity, Indian Health Services and Concentric by Ginkgo. Pooling can test 5 to 25 people using one test. All tudents in a class, pod, or cohort swab their own noses and place their swabs in a single tube (that's the pooling tep). The samples in that tube are then run as a single sample, using one test. If the result comes back with a positive ur school nurses administer individual antigen tests on each pool member to find the positive individual. TCUSD on ach campus and department has additional rapid test for individuals and students who show symptoms. This rovides and additional step to peed the contact tracing if needed.

Tuba City USD provides equitable learning experiences that ensure all students' academic needs are met by providing the following:

- 1. Administration of universal screeners (reading and math), benchmark assessments and summative semester assessments to identify skill gaps and proficiency of academic standards to better inform instruction in the classroom and for intervention.
- 2. Extension of the school day and year to include before/after school intervention and support, summer school (K-12)
- both in person and online.
- 3. Credit recovery options (in-person and online).
- 4. Intervention and tutoring support during and after the school day.
- 5. Review of district curriculum maps, creation of curriculum crosswalks and identification of priority standards.
- 6. Embedded time for teachers to engage in instructional conversations with professional learning community (PLC) colleagues and campus administrators. Safe Return to In-Person Instruction and Continuity of Services Plan (ARP Act)
- 7. Chromebooks / Laptops for all brick and mortar K-12 students and all K-12 online students.
- 8. Implementation of instructional framework to support administrators, teachers and students.

This program is designed to assist employees in resolving personal problems that may be adversely affecting the employee's performance. The district also continues to provide employees with ADA accommodations and PPE such as masks, shields, and plexiglass, if requested.
