Briefly describe an overview of the continuity of services and in the following questions you will provide more detailed information.

TCDS will ensure continuity of services by establishing refined systems that, by design, meet the current academic and social emotional needs of students, as well as the mental health needs of staff. TCDS has developed a SEAL Team (Social Emotional Academic Learning Team) with specialists who work with teachers in helping refine their curriculum to meet the needs of students, as well as to work one-on-one with struggling students in the areas of math, literacy, and social emotional learning. We've also devised a "Champion Check in" which is a community building exercise conducted twice a day for each student in their class, as well as every week with staff in the Professional Learning Communities (PLCs). These routine check ins allow a dedicated time for SEL development and mental health checks.

26. How will the LEA ensure continuity of services for students' academic needs?*

All students are provided with daily in-person instruction in Math, ELA, Science, and Social Studies. Students are provided both hands-on learning opportunities as well as use of online learning platforms such as ST Math, E-Spark, and IXL.

27. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?*

All students are provided with Social Emotional Learning lessons each week in what's called a "Champion Check in". TCDS subscribes to the Second Step SEL curriculum which is implemented in these daily "Champion Check ins".

All staff participate in weekly PLC meetings that are all opening with a check on staff mental and social emotional needs. This "Champion Check in" serves a similar purpose as with the students, to gauge the emotional and mental state of the staff and to give the staff a weekly platform to open up, share needs, concerns, or growth.
