Describe the process used to seek public input, and how that input was taken into account in the revision of the plan:	<p>In July, newsletters included information about health practices in place and all staff professional development included a presentation of health practices in place and teacher responsibilities.</p> <p>In August, we had items in newsletters, parent forums at individual campuses and a board meeting summary with over 30 parents in attendance who spoke as part of the Call to Public. Changes to the details of the plans have been made based on parent and teacher input as well as the number of cases in our schools. Ongoing: There is a weekly Health and Safety committee meeting that reviews the data and discusses procedures. The formation of a Parent COVID Advisory Board is underway with a kick off in early September.</p> <p>Health Plan is posted on the website with a link for input.</p>
